## Washington Township School District One-to-One Laptop Initiative



#### Important Insurance Information

Laptop Warranties: The District has purchased a warranty for each laptop. This warranty covers the cost of repairs/replacement of the laptop caused by mechanical/electronic failure or factory defect. Optional Insurance Coverage also is being provided to safeguard against accidental damage or theft.

# Damage Not Covered by Warranty

 Damage to the laptop and accompanying peripherals such as chargers (AC adapters), batteries, and carrying cases are not covered under the manufacturer's warranty unless there is evidence of a factory defect. Please note that replacement and repair fees will be charged for damaged laptop chargers, batteries, and carrying cases.

 Accidental damage is NOT covered by the manufacturer's warranty. It is the responsibility of the student and their parents/guardians to pay for repairs and/or replacement for the damage caused by accident, negligence, or theft.

#### Theft

 If at any point a laptop is lost/stolen during the school day, the student is to immediately report the incident to the Tech Support/Repair Center or to an administrator and complete required paperwork.

 If at any point a laptop is stolen away from school property, the student and parents/guardians should contact local police and complete a police report within 24 hours. A copy of this report must be supplied to school administration within 24 hours (barring weekends).

#### Insurance

 Washington Township parents/guardians may purchase optional insurance coverage to guard

against accidental damage or theft of laptop. If an investigation by the District determines that a student is guilty of negligence, insurance coverage will not apply. Please note that multiple insurance incidents per year may result in the student and parents/guardians being dropped from insurance coverage or being charged an additional fee. Instances requiring complete replacement of the laptop due to loss, damage or theft will result in the student being charged an additional insurance fee to cover the replacement laptop.

 In order to maintain insurance coverage, students are required to use the District-issued case at all times.

This insurance will provide protection against costs/fees associated with accidental damage and/or theft of the District-issued laptop. Checks or money orders made payable to Washington Township Board of Education must be hand-delivered with the signed "Initiative Student Guidelines Agreement Form" when picking up the laptop during the laptop distribution.
