Orchard Valley Middle School Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

The Orchard Valley Middle School agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required school level parental involvement policies meet the requirements of section 1118 of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

The school will convene the meeting at a time convenient

for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend by:

- a) Sending home a letter notifying them of the meeting
- b) Scheduling meetings at a time that is convenient for parents
- 4. Orchard Valley Middle School will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress and the proficiency levels students are expected to meet by:
 - a) A parent letter with Title I program information will be sent home at the beginning of each school year
 - b) Title I information will be made available at Back to School Nights for parents at the beginning of the school year
- 5. Orchard Valley Middle School will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

Presenting said suggestions to administration and staff, when appropriate, and implementing changes as needed.

6. Orchard Valley Middle School will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

Individual student test reports will be sent to parents upon receipt from the state.

7. Orchard Valley Middle School will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term on section 200.56 of the Title I Final Regulations (67Fed. Reg. 71710, December 2, 2002) by:

If this becomes necessary, parents would be notified by letter prior to the end of the fourth consecutive week.

- 8. Orchard Valley Middle School will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph:
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments, the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:

Parents would receive information and explanations of these topics at Home and School Council meetings and evening presentations that would focus upon these specific topics.

- 9. Orchard Valley Middle School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
 - a) Inviting parents to observe classrooms during American Education Week
 - b) Holding annual Back to School Nights at the beginning of the school year to inform parents of their child's educational program at each grade level.
- 10. Orchard Valley Middle School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and school, by:
 - Providing opportunities for professional development in building community partnerships and parent involvement.
- 11. Orchard Valley Middle School will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with various programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
 - a) Providing a parent resource library which is housed in the Orchard Valley Middle School media center
 - b) Presenting relevant programs at the bi-monthly Home and School Council meetings

12. Orchard Valley Middle School will take the following actions to ensure that information related to the school and parent programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

Newsletters and parent letters would include information about parent meetings and programs. These would also be listed on the school website.
