

SECTION 504 PROCESS – For WTPS Parents



#### <u>STEP 1:</u>

- Parent requests Section 504.
- Section 504 Coordinator/School Counselor speaks with parent to explain the Section 504 is about equal access to education by describing the process, emails C1 REFERRAL FOR SECTION 504 ASSISTANCE, and shares link to the school's Section 504 Website.

## <u>STEP 2:</u>

After Section 504 Coordinator/School Counselor receives C1, email parent
C2 ACKNOWLEDGEMENT OF REFERRAL, C3 SECTION 504 PROCEDURAL SAFEGUARDS
AND PARENTAL/STUDENT RIGHTS, C4 PHYSICIAN CERTIFICATION, and
C5 AUTHORIZATION FOR RELEASE OF STUDENT RECORDS.

## <u>STEP 3:</u>

- After Section 504 Coordinator/School Counselor receives **C4** and **C5**, email parent **C6 CONSENT TO EVALUATE FOR SECTION 504**.
- Share **C8 TEACHER INPUT FOR DETERMINATION OF ELIGIBILITY UNDER SECTION 504** to all teachers responsible for the student's instruction.
- For an intergrative process, the Section 504 Coordinator/School Counselor may call the **C4** physician using the **C5** for further clarification, which might be done in conjunction with the school nurse.
- This process is typically completed within 30 days.

### <u>STEP 4:</u>

- After Section 504 Coordinator/School Counselor receives C6, parent and appropriate school personnel will receive an email invitation using C7 SECTION 504 PARENT MEETING NOTICE.
  - The Section 504 Team consists of a group of professionals with knowledge of the student who understand the evaluation data.

### <u>STEP 5:</u>

- The Section 504 Meeting is held with all interested parties to determine student's eligibility for a Section 504 Accommodation Plan.
- Section 504 Team reviews the evaluation data and will consider the following:
  - ✓ C1 REFERRAL FOR SECTION 504/Parent Referral
  - ✓ C8 TEACHER INPUT FOR DETERMINATION OF ELIGIBILITY UNDER SECTION 504/ Teacher Reports
  - ✓ Classwork Samples
  - ✓ Grades
  - ✓ Standardized Tests / Other Assessments

- ✓ School Records
- ✓ Attendance Report
- ✓ Disciplinary Report
- ✓ C4 PHYSICIAN CERTIFICATION/Medical Report
- ✓ School Nurse / Health Report
- ✓ Psycho-Educational Evaluation
- ✓ Other Pre-referral Interventions
- ✓ General Education Classroom Accommodations Already in Place
- ✓ Intervention & Referral Services (I&RS) Information
- ✓ Child Study Team (CST) Referral Information
- ✓ Participation in Extracurricular Activities
- To determine eligibility, the following questions must be addressed:
  - Does the student have a *physical or mental impairment*?
  - Does the *physical or mental impairment* affect one or more *major life activity* (including major bodily functions)?
  - Does the physical or mental impairment substantially limit a major life activity?
  - Does the student need 504 accommodations/services in order for his/her educational needs to be met as adequately as those of non-disabled peers?
- The Section 504 Coordinator/School Counselor guides the Section 504 Team through the eligibility process and completes the **C9 SECTION 504 TEAM ELIGIBILITY DETERMINATION**.
- If the student requires a Section 504 Accommodation Plan, it will be developed within 30 school days and documented using the **C10 SECTION 504 ACCOMMODATION PLAN**.
  - $\circ$  The accommodations must be directly correlated to the disability of record.

### <u>STEP 6:</u>

- The Section 504 Team Coordinator/School Counselor maintains a copy of all completed forms listed in STEPS 1 to 5 in the School Counseling Office and Realtime.
- Questions related to the Section 504 process can be directed to the Section 504 Team Coordinator/School Counselor or building principal.

# <u>STEP 7:</u>

 Annually, the Section 504 Team Coordinator/School Counselor gathers information from the student's teacher(s) using the C4 PHYSICIAN CERTIFICATION, C5
AUTHORIZATION FOR RELEASE OF STUDENT RECORDS, C12 SECTION 504 PROGRESS
REVIEW and the Section 504 Team using the C13 SECTION 504 PLAN REVIEW to recommend continuation of present services with no changes, modify the present Accommodation Plan, conduct additional evaluations, or exit/terminate from Section 504 services based upon the above evaluation results/rationale.
