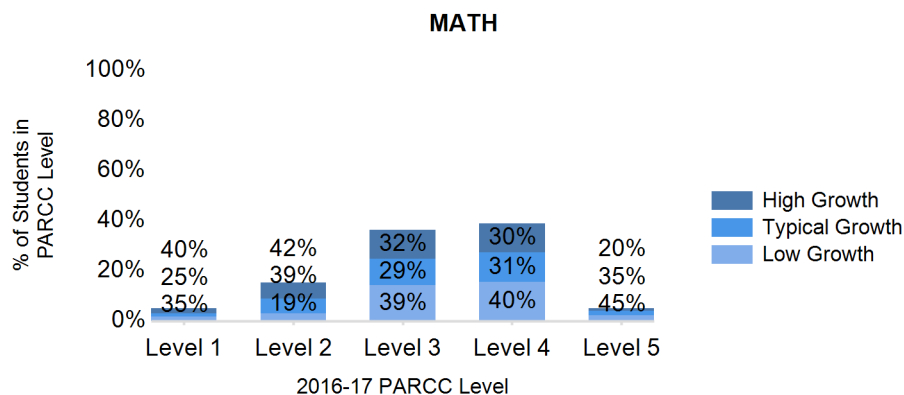
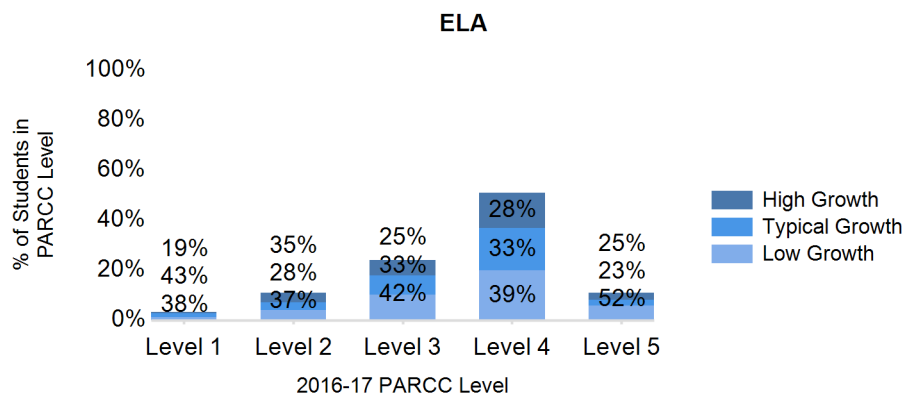

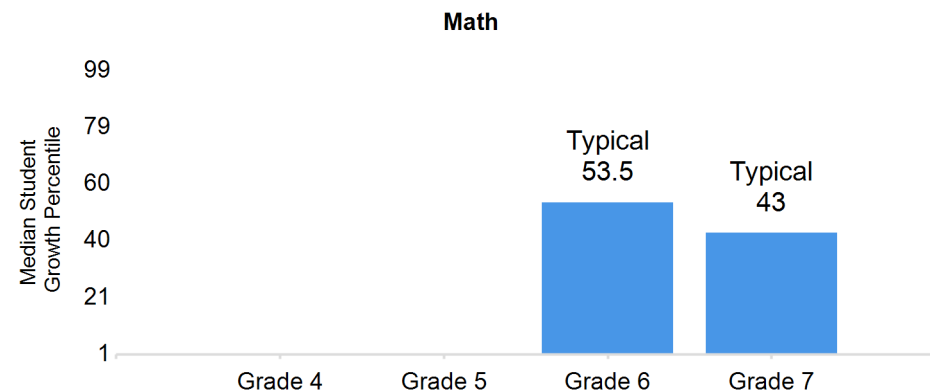
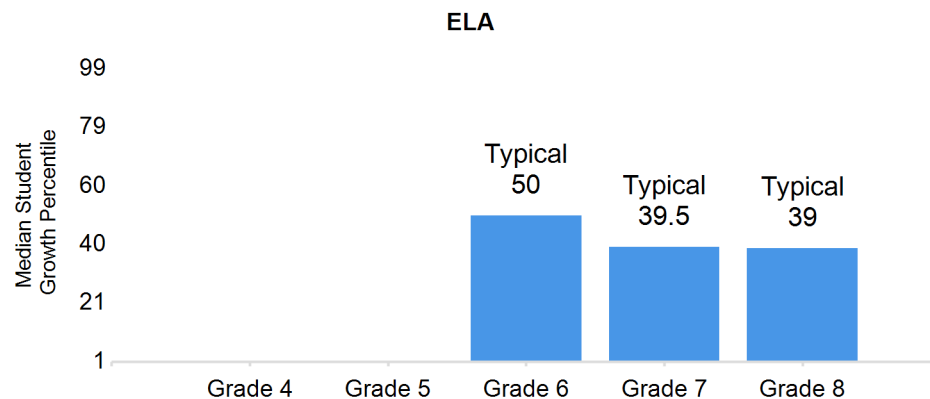
**Student Growth by Performance Level**

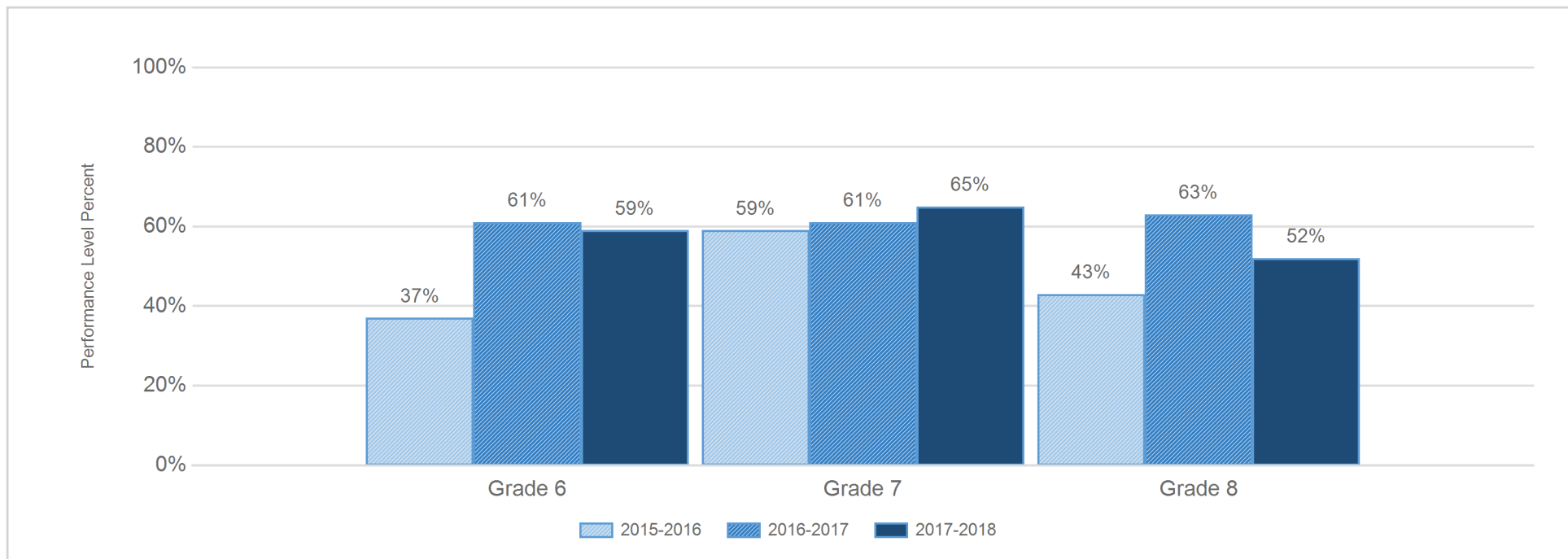

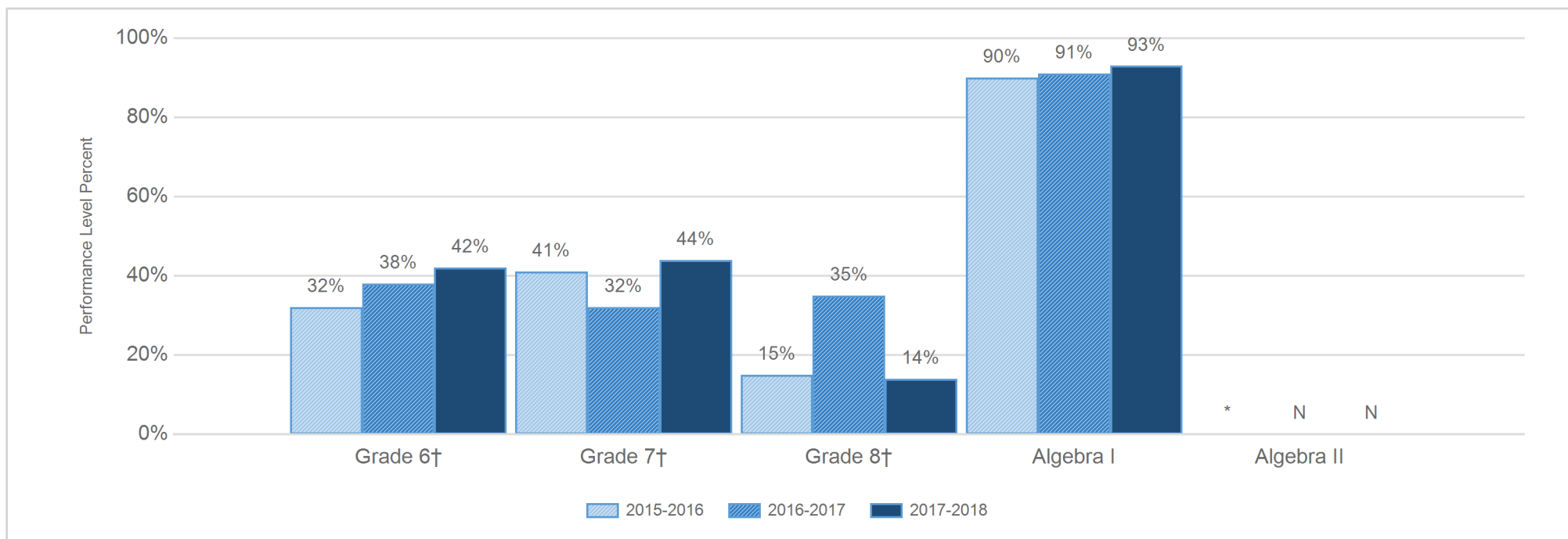

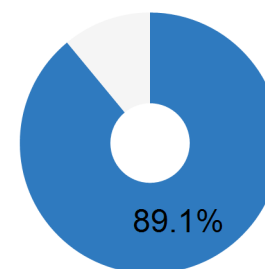

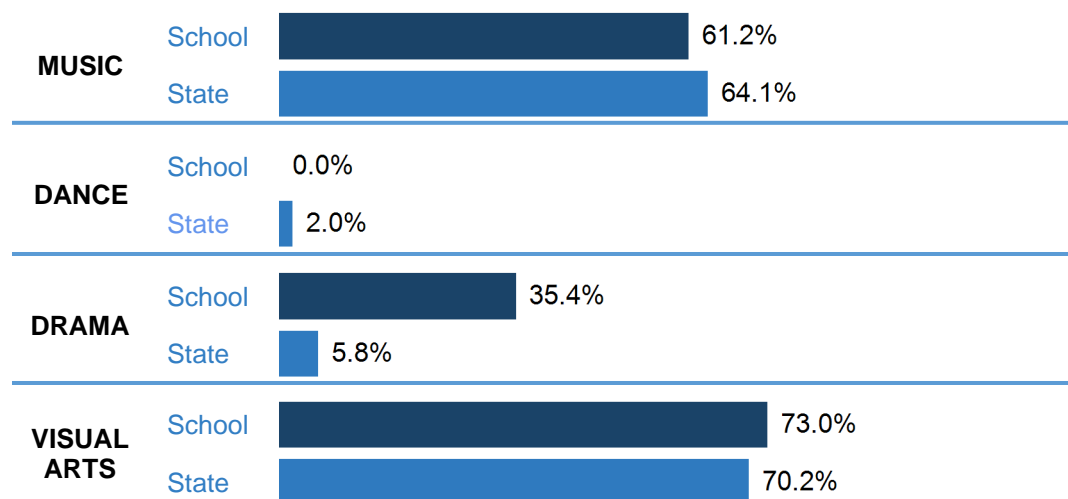

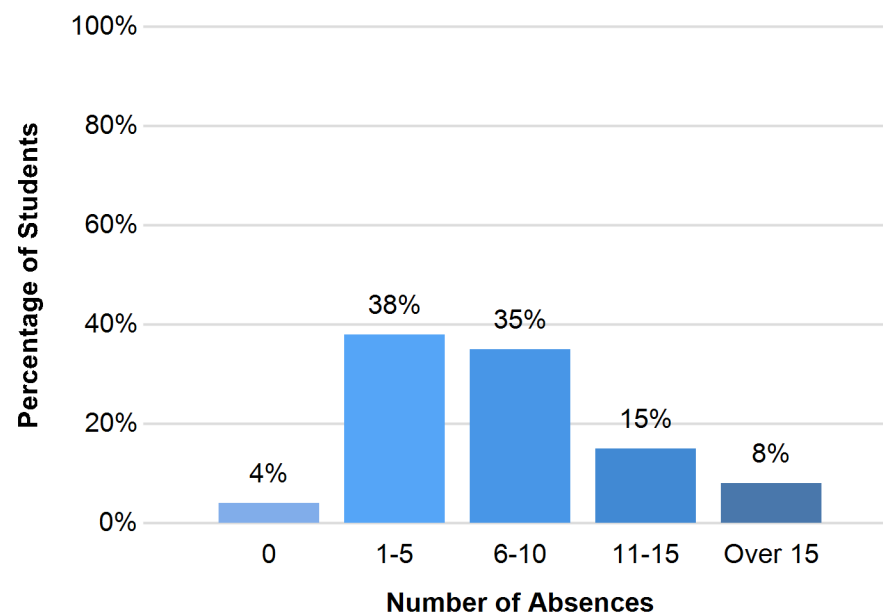

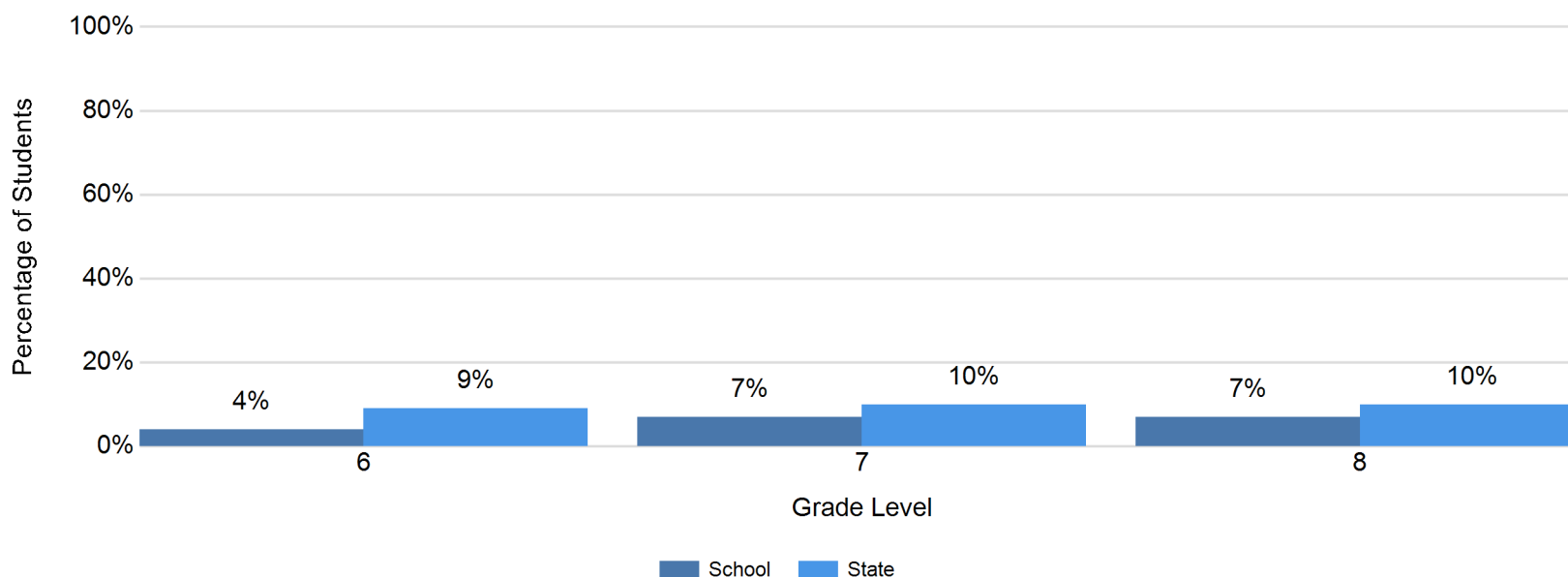
