

2415.52. TITLE I - SCHOOL PARENT AND FAMILY ENGAGEMENT - WEDGWOOD ELEMENTARY SCHOOL

- A. District Expectations
1. In accordance with the requirements of Title I, Section 1116(a)(2), ESEA, the Board of Education agrees to implement the following statutory requirements:
- a. The school district will put into operation programs, activities, and procedures for the involvement of parents in all its schools with Title I, Part A programs. These programs, activities, and procedures will be planned and operated with meaningful consultation with parents of participating children.
- b. The school district will work with its schools to ensure the required school-level parent and family engagement policies meet the Title I, Part A requirements, and include, as a component, a school-parent compact.

5.  - (c) *Wedgwood School will host family workshops and parent nights featuring opportunities for parents to explore topics related to Title I requirements and supports aimed at accelerating academic progress.*
 - (d) *Wedgwood will share test results from Standardized testing, as well as school level testing, such as iReady, with parents throughout the year.*
6.  - b. The school will, with the assistance of its Title I schools and parents, educate its teachers, student services personnel, principals, other school leaders, and other staff in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners to implement and coordinate parent programs and build ties between parents and schools, by:
 - (1) *establishing best practices and shared expectations in parent communication through discussions at faculty meetings*
 - (2) *disseminating parent resource guides and links for core curriculum programs for Math and English Language Arts, such as Eureka Parent links/guides and Amplify Family Resources*

The school will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with Head Start, Home Instruction Programs for Preschool Youngsters, Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
