School Parental Involvement Policy

Bunker HIII Middle School recognizes the importance and power that effective collaboration and communication between the home and school have on student achievement. The Bunker HIII Middle School Parental Involvement Policy is a document that formalizes this understanding. PART I. GENERAL EXPECTATIONS

Bunker HIII Middle School agrees to implement the following statutory requirements:

- Bunker Hill Middle School will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA:
 - a) Present and discuss the School Parental Involvement Policy to parents at a meeting to be held at the beginning of each school year to be informed of the academic support program, criteria, and support available for their child/children.

- 2. Bunker Hill Middle School will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:
 - a) Conduct monthly HSC meetings where a review of school programs and school improvement will be discussed.
- Bunker Hill Middle School will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend.  - a) Sending a letter home notifying them of the meeting.
 - b) Schedule meetings at a time that is convenient for parents.
 - c) Providing childcare, if needed, to encourage parent attendance.
 - d) Provide breakfast meetings to encourage parent attendance.

- 4. Bunker Hill Middle School will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
 - a) A parent letter with Title I program information will be sent home at the beginning of each school year,
 - b) Title I information will be made available at Back-to-School Nights held for parents at the beginning of the school year.
- Bunker Hill Middle School will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - Presenting said suggestions to administration and staff, when appropriate, and implementing changes as needed.
- 6. Bunker Hill Middle School will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading.
 - Individual student test reports will be sent to parents upon receipt from the state.
- Bunker Hill Middle School will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002).
 - If this becomes necessary, parents would be notified by letter prior to the end of the fourth consecutive week.
- Bunker Hill Middle School will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph -
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:

- Bunker Hill Middle School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
 - a) Hold annual Back-to-School Nights at the beginning of each school year to inform parents of their child's educational program at each grade level.
 - b) Invite parent involvement in classroom activities such as, reading and listening to the students read, assisting with center activities, and participating in classroom celebrations.
 - c) Invite parents to visit their child's classrooms throughout the school year and during American Education Week.
 - d) Invite parents and children to participate in Family Fun Nights sponsored by P.T.O.

- 10. Bunker Hill Middle School will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with various programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
 - a) Parent website with parent resource links to assist parents at home, including special education information links.
 - b) Presenting relevant programs at monthly HSC meetings.

Bunker Hill Middle School will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
